Selection Process and Roles

Head of Performance/Lead Coach

- Create and present criteria, roles and balance of how squad is selected
- Voting rights for lead coach

Chair of Selectors

- Facilitate, check and challenge the meeting according to Head Coach's criteria and squad balance
- No voting rights

Advisor

- Hold the panel accountable to the criteria and ensure the principles of fairness and acting without bias
- No voting rights

Observers

- Observe and scrutinise process, ensure the interests of athletes are prioritised, and hold panel accountable to the criteria and ensure principles of fairness and acting without bias
- No voting rights

Selectors

- Make selections based on criteria presented by Head Coach
- Voting rights

Selection Criteria

The selection panel will consider only the following criteria when selecting the Men's National squad, decided by the Head Coach/Lead Coach:

- Strongest possible World Cricket League Performance
- Providing match play opportunities for players to evidence their form and progress after some long layoffs
- Ensuring the best possible preparation for ICC Men's T20 World Cup 2024
- Developing and transitioning players for the future

In the event of the three voting members all voting for a different player to be included, the casting vote will be with the Head Coach/Lead Coach.

For any of the criteria, the voting members, led by the Head Coach/Lead Coach, need to consider what data they will bring to the panel meeting and even where it is qualitative data, how they have arrived at that decision.

The Selection Panel will take into account the need to select a squad that enables the ability to select a balanced team throughout the tour.
